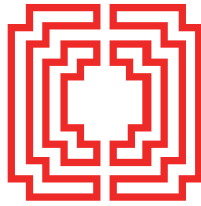

The Board further announce that Mr. WONG Wai Chi (**Mr. Wong**) has been appointed as the Joint Company Secretary, an Authorized Representative and the Process Agent with effect from July 12, 2022. Mr. WANG Jian will continue to serve as the other Joint Company Secretary.

The biographical details of Mr. Wong are set out as follows:

Mr. Wong is currently the associate director of SWCS Corporate Service Group (Hong Kong) Limited. Mr. Wong has extensive experience in compliance and listed companies secretarial work.

Mr. Wong is a fellow of the Hong Kong Chartered Governance Institute (previously known as the Hong Kong Institute of Chartered Secretaries), a fellow of the Chartered Governance Institute, a member of CPA Australia, a member of the Hong Kong Trade Association and a Certified Training Practitioner.
